PROGRAM DESCRIPTION

Program Title

C.A.R.E. Program (Chatom After-School Recreation and Education Program)

Program Goal

To provide an after-school program that provides a fun, safe, and encouraging environment for continued learning and development at a familiar location.

Program Type

A program that combines a wide variety of educational and recreational activities for elementary school students to encourage continued learning and development outside of the regular school day.

Program Secting

C.A.R.E. will be located at Chatom Elementary School, within an indoor classroom facility.

Program Staff

The school site will be staffed with one Program Coordinator and additional staff members to accommodate the program growth. All current and future staff members meet Chatom Union School District professional requirements and have been fingerprinted.

Program Schedule

C.A.R.E. will run from 2:00 p.m. to 6:00 p.m. each regular school day and 1:00 p.m. to 6:00 p.m. on each minimum school day. Children must be picked up by 6:00 p.m. daily. If late pick-up occurs more than twice, the parent or guardian will be charged \$1.00 per minute (per child) for every minute they are left after 6:00 p.m. Also, the child or children may be suspended or dropped from the program.

Daily activities may vary, but will adhere to the same basic schedule Monday, Tuesday and Thursday. Wednesday's schedule will be very similar but will include more outdoor games and whole group time. Friday's schedule will not include homework time but, will instead include fun activities for the students the entire time the program runs.

The daily schedule is as follows:

2:00 p.m. - 2:55 p.m. - Kindergarten - 2nd grade Whole group Time, Homework Time, and Activity Time
2:55 p.m. - 3:30 p.m. - Kindergarten - 2nd grade - Outside Time/Snack
3rd - 5th grade - Check-in with Teachers/Snack/Outside Time
3:30 p.m. - 4:15 p.m. - 3rd grade - 8th grade - Homework
Kindergarten - 2nd grade - Free time

4:15 p.m. - 4:30 p.m. - Outside Break/ Snack

4:30 p.m. - 5:30 p.m. - Activity (Craft, Games, puzzles, coloring etc...), Independent reading, AR Reading and Testing or Additional Homework.
5:30 p.m. - 6:00 p.m. - Clean (Jp

Program Participants

Chatom Elementary School students in grades TK through 5th grade and Mountain View Middle School students in grades 6th through 8th Grade.

First priority shall go to pupils who are identified by the program as homeless youth, as defined by the federal McKinney-Vento Homeless Assistance Act(42 U.S.C. Sec. 11434a), at the time that they apply for enrollment or at any time during the school year, and to pupils who are identified by the program as being in foster care. If the program is at full capacity, current program participants need not be removed to make room for new homeless and foster youth. AB 1567 clarified that its new priority provisions "shall not be construed to require or authorize the disenrollment of current participant in order to secure the enrollment of a pupil who has priority for enrollment. "However, new homeless and foster youth should be placed at the top of the waiting list (EC sections 8483[C][3] and 8483.1[d][3]). Fees must be waived for pupils identified as homeless or foster for the base program as well as summer/supplemental programs (EC Section 8482.6[a].

Program Activities

A variety of activities will be provided daily. They may include: Sports/Outdoor Activities, Music, Performing Arts, Dance, Art/Crafts, Science Projects, Math Activities, Educational videos, Guest speakers, Field trips

Program Payment Options and Daily Fees

Daily Fee per student - \$7.00

\$6.00 fee per day for each additional child from the same family There are three payment options - Weekly, Monthly, and Scholarship Weekly:

Fees for the program are due weekly, and can be paid by cash, check, or money order (made payable to Chatom Union School District). Payment is due the last school day prior to the week of attendance. A late fee will be added if payments are not made on time.

Monthly:

Fees for the program are due prior to the first day of the month and can be paid by cash, check, or money order (made payable to Chatom Union School District). A monthly fee breakdown will be provided upon request. Payment is due the last day prior to month of

attendance. A late fee will be added if payments are not made on time. Scholarship:

Students will not be turned away for inability to pay. Scholarships are available to students who qualify.

Parental/Guardian Responsibilities

Parents/guardians are responsible for checking their child out of the program each day he/she attends. The only people authorized to pick up students from C.A.R.E. are those adults, 18 and older, whose name appears on the student's emergency form. The program reserves the right to ask for identification of anyone picking students up from the program.

Children must be picked up by 6:00 p.m. daily. If a child is not picked up by 6:00 p.m. the parent or guardian will be charged \$1.00 a minute (per child) for every minute after 6:00 p.m. If late pick up occurs more than twice, the child may be suspended or dropped from the program.

Children signed up to attend are expected to do so. Excused absences (as indicated by the school office) are acceptable. If your child attends school for the day, but will not be able to attend C.A.R.E., please contact the program directly to let us know. Occasional absences are understood, but excessive unexcused absences may result in your child being suspended or dropped from the program.

The program provides a nutritious meal every afternoon. Some children need more than just that amount of food. Parents are encouraged to send their child to C.A.R.E. with a nutritious snack each day. Many students become hungry after school hours, and one snack may not be enough.

Meals and snacks provided at C.A.R.E

Proper nutrition in the school age years can reinforce lifelong eating habits that contribute to a student's overall wellbeing. Proper nutrition improves academics, behavior, and self-image. Knowing the tie between proper nutrition and our educational goals we will provide the following programs free of charge to all students who attend C.A.R.E.

- Super Snack- Students attending C.A.R.E receive the benefit of participating in The Child and Adult Food Care Program (CAFCP). This program provides a nutritionally balanced meal to all students in attendance free of charge. Students attending C.A.R.E visit the cafeteria at 3pm daily to enjoy their "Super Snack".
- After school snack- The Afterschool Meal Supplement Program provides a nutritious snack to C.A.R.E students daily at approximately 5pm. This snack is provided at no cost to parents and meets nutrition guidelines required by both state and federal regulations.
