 - Chatom Elementary School

Chatom Principal, Sara Cruz, reported that the month of February was a month to focus on love. Every morning students were given a moment to express a positive affirmation about themselves. In February all the students had the opportunity to show love with "Valentine Grams." All the students, and staff at Chatom enjoyed sending a message with a Valentine Gram, students also got to send Valentine grams to family members, which made it more fun and exciting for the students. Prior to Valentine's Day the students all worked on making a personal, creative Valentine's box for their cards. On Valentine's Day all the students had many different fun activities and did their card exchanges. For the month of February there was also a date that they had fun with, 2-22-22. They completed fun activities with the unique day of all 2's. The character trait focused on for the month of February was "integrity." This character trait helped all the students at Chatom focus on doing what is right, even when no one is looking. To promote the character trait of the month, students chose a card with a random act of kindness task for the day that promoted a positive outlook on being kind to others. Mrs. Olvera shared that every year the Stanislaus County Office of Education (SCOE) gives each District an opportunity to select a teacher-of-the-year and she was happy to announce that Kelli Redman was selected to represent our District for the 2021-2022 school year.
